TENNIS RULES AND REGULATIONS

Ahwatukee Community Swim & Tennis Center is owned and operated by the Ahwatukee Board of Management (ABM). The Rules and Regulations of the Ahwatukee Community Swim & Tennis Center are subject to ABM regulations and policies.

1. MEMBERSHIP TYPES (non-Equity)

- 1.1 Types of memberships
 - A. Family-Includes children living at home to age 18. (Resident & Non-Resident)
 - B. Single-One Adult (Resident & Non-Resident)
 - C. Junior (up to age 18) (Resident & Non-Resident)
 - D. 3-month membership.

2. MEMBERSHIP PRIVILEGES

- 2.1 Members will be eligible to participate in, tournaments and social events for a nominal cost.
- 2.2 Members may reserve courts. Courts may be reserved 7 days in advance for 90 minutes use. There is a reservation limit of one court per family member at the same time.
- 2.3 Members may bring guests to play at the Club up to 5 times in a 12-month period for a fee of 5.00 per visit, per guest.
- 2.4 Members have court reservation priority.
- 2.5 Monthly registration fee for tennis lessons is waived for members.
- 2.6 Members may use the swimming pool during open swim hours.
- 2.7 Members may use the Fitness Room during posted hours.
- 2.8 When new or current members pay for a year membership in full, they will receive a 5% discount on their yearly membership dues.

3. CLUB ACTIVITIES

- 3.1 A Club Activities Coordinator may be appointed by management to plan and oversee member activities, including but not limited to; leagues, tournaments and socials. The Club Activities Coordinator must have management's approval before implementing the activity.
- 3.2 Management may form advisory committees made up from the membership, to serve any needs of the Club as determined by management.

4. CONDUCT

- 4.1 Proper tennis attire must be worn on the courts by members and their guests.
- 4.2 Shirts must be worn always on the courts and in the Community Center.
- 4.3 Tennis shoes must always be worn on the courts.
- 4.4 At no time will profanity, throwing of racquets, unsportsmanlike conduct, boisterousness, or any loud or obnoxious behavior be tolerated. Anyone behaving in such a manner will be asked to leave ABM's premises. Behavior of this nature constitutes grounds for suspension or termination by management at its discretion. If such action arises, any monies owed to fulfill the contract will become due and payable.
- 4.5 Children on the premises are expected to behave in such a manner that other players will not be disturbed.
- 4.6 No firearms, weapons, or any other such devices of any kind are permitted anywhere on ABM property.
- 4.7 The Ahwatukee Community Swim & Tennis Center and ABM will not be responsible for the loss of property or any other loss sustained by members or their guests.
- 4.8 Members may be charged for any damages to ABM's property because of their own, or their guests' actions whether intentional or non- intentional.
- 4.9 Management reserves the right to overrule court distribution.
- 4.10 Members are encouraged to join our teams and competitions which require a "home court". Tennis teams that have use of our courts represent the Ahwatukee Community Swim & Tennis Center. Teams must have at least 2 members in good standing for each court required by the association it is playing for (Arizona Tennis Association, Interclub, Arizona Play Tennis, USTA, etc.). All tennis league captains must be members in good standing.
- 4.11 All newly formed leagues must be approved by Ahwatukee Community Swim & Tennis Center management.
- 4.12 Employees are not to be interfered with or reprimanded by members. All complaints or suggestions will be made to management in writing and signed by the member.
- 4.13 Ahwatukee Board of Management and the Ahwatukee Community Swim & Tennis Center and their staff are not and will not be responsible for any unattended students or children of members and their guests.

5. GUEST RULES

- 5.1 Guest fee must be paid prior to guest(s) entering courts or playing tennis.
- 5.2 All guests must be accompanied by a member in good standing or be approved by management.
- 5.3 Guest fees are required and determined by management.
- 5.4 All tennis guests will be limited to a maximum of 5 times each year, unless approved by management.
- 5.5 Special passes for tennis guests are available through arrangements with the Director.

6. MEMBERSHIP RULES

- 6.1 Persons holding memberships have Membership Privileges (Section 2.) for themselves only. They must pay a guest fee for any participating non-member.
- 6.2 Monthly dues for memberships are subject to periodic change by management. A minimum of two months notice will be given to members, via e-mail or our website, of any change in monthly dues.
- 6.3 Members play at their own risk.
- 6.4 Members are responsible for monthly dues even if they do not utilize the facility. Accounts are payable the first day of every month. Accounts not paid by the 25th of the month will be charged a \$10.00 late fee.
- 6.5 Accounts that have become two months behind in payment of dues will be suspended from use of the facilities on the first day of the following month unless the balance in full is paid. Suspension of Tennis Membership includes court time, use of ball machine, socials, leagues, clinics, team and tournament play and group or private lessons, any other program that the ABM offers or any use of ABM's property or facilities including rentals. However, membership dues will accrue and be payable while membership is suspended due to delinquency.
- 6.6 All reasonable legal fees and costs expended by ABM for collection of delinquent membership dues and late charges will be the sole responsibility of the member(s) involved. Past due accounts may be charged 1 ½ % interest on the total amount due per month until collected.
- 6.7 Junior memberships will automatically have converted to Single Adult memberships, and subject to its pricing, the first month proceeding the member's 18th birthday.
- 6.8 Junior Tournament Members must be current with monthly payments to participate in the monthly tournaments.
- 6.9 If a member should move in or out of the Ahwatukee boundaries set by the Ahwatukee Board of Management, the member's rates will be adjusted to reflect the resident or non-resident rate.
- 6.10 Members may not give tennis lessons without consent of tennis professional staff.

7. CHANGES TO MEMBERSHIP

- 7.1 Change of Membership Forms are available at the Club or by email. To upgrade, for example, Junior to Single, or Single to Family, members must assume the higher monthly dues. To downgrade the membership, for example, Family to Single or Family to Junior, the member assumes the lower monthly dues. No refund of initiation fees or any other fees will be given. After downgrading, if the member decides to upgrade again, the member assumes the higher monthly dues. The member must be current before the transfer will be enacted.
- 7.2 Members wishing to Cancel their membership must notify the club in writing by the 15th day of the month preceding the requested cancellation date. All dues must be current before the membership will be cancelled. It is the member's responsibility to ensure the Club receives the written cancellation notice by the required time. Cancellation forms are available at the Club by request.
- 7.3 Members who cancel their membership before the contracted date will be responsible for 50% of the remaining dues.
- 7.4 Members wishing to put their tennis memberships on Inactive Status must notify the club in writing. Membership Inactive Status may be used 3 consecutive months in a calendar year. The rate for inactive status is 25% of your regular monthly dues. Members must be current on their tennis account before any change will be honored. You may request Inactive status by email or phone.

8. MISCELLANEOUS

- 8.1 Club hours are posted online at www.ahwatukeecommunitycenter.com and in the brochure and are subject to change by management.
- 8.2 The Club may insert non-members into Club activities as necessary to fill the draw so that members may participate in an activity, however, guest fees will apply.
- 8.3 Existing management policy will be in effect for all items not specifically noted herein.
- 8.4 Members paying a full year membership will receive a 5% discount on the yearly dues.
- 8.5 Date of this revision is November 18, 2019 and supersedes all prior Rules & Regulations.
